Risk Statement	
 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By allowing your child to take part in the event you acknowledge that: I am aware of the inherent element of risk involved in the sport and you accept responsibility for exposing my child to such inherent risk whilst taking part in the Event; I have satisfied myself that my child has the necessary skill and knowledge to take part in the event and to deal with conditions that may arise in the course of the event; I will not allow my child to participate in the event whilst under the undue influence of alcohol, drugs or whilst otherwise unfit to participate; I am responsible for ensuring that the boat is in good order, equipped and insured (including third party insurance for at least £2 million) to take part in Junior racing; I am responsible for my child's property whether afloat or ashore; I accept responsibility for any injury, damage or loss to the extent caused by my own actions or omissions or actions or omissions of my child; The provision of safety boat cover, race officials and other volunteers does not relieve me of my parental/guardianship responsibilities or my child of his/her responsibilities. The provision of safety boat cover is limited to such assistance, particularly in extreme weather conditions, as can be provided in the circumstances; My child will comply at all times with the instructions of the Officer of the Day and other race officials.
